An issue of major concern to the residents of our village has been the recent notification of inspection of our septic systems. I hope you find the articles provided within to be informative.

Robertson Pumped Up Over Pump Outs. By Nicki Boehme.

Nearly 100 residents of Robertson attended a meeting at the School of Arts to protest the State Government's new regulations regarding the management and inspection of septic systems.

Council's Health Manager, Paul Curley, explained that all NSW Shires were required to carry out inspections of septic tanks in their areas. Property owners must apply to operate a sewage system at the cost of \$20.

There were strong objections to a clause in the application allowing Council offices to enter properties without notice. Whilst acknowledging that the State Government imposed the new system, it was felt that Council had created unnecessary hardship by requiring new or replacement due to "failure" installations be "pump out" systems with on-going costs of \$56 per fortnight.

The reported aim of the exercise was to prevent pollution of Caalong Creek, which drains into Wingecarribee Dam. Mr. Curley agreed that, up to now, there was no evidence of any such pollution. Mick Wren, President of the Robertson Village Association. made the point that the village was established over 100 years before the dam. Sydney Water, and the State Government, should be held responsible for any dam pollution caused by their placing of the dam beneath the village. Calls have been made for them to fund the immediate sewering of Robertson to eliminate such risks, and not have them expect residents, or Council, to pay for someone else's mistakes.

"Not only is the government refusing to put in sewerage systems, the cost of their band aid remedy is being shifted onto Local Government so it doesn't cost the State Government a cent.....Mr. Carr has passed the buck to the bush once again."

The association was started with the view of being able to represent Robertson residents on a wide range of issues. Robertson by virtue of its unique position has unique problems. At the moment the main items on our agenda are footpaths and sewerage.

The provision of footpaths from Ranelagh to the village and, most importantly, Caalang Street is important as they provide a means of getting around town and these sections of road are plain dangerous to an extreme.

The issue of sewerage was backed up by a public meeting we held a last month. It was felt that many issues hadn't been thought through on either a state or local level. The reaction of the residents present should have made it clear to Council that there is a lot of public anger at the way sewerage had been handled and that people can be hit hard in the pocket. There must be proper public consulation and It has to be done right.

There would be few who would disagree for the need for our sewerage systems to work properly, after all they are on our land and affect our families directly. The meeting went a long way to addressing important issues.

We would like to thank Councilors Tuddenham and Gair, Mr P. Curley and Ms Mitchie for their attendance. It is not easy for council members to

attend a public meeting and they showed themselves to be truly concerned in dealing with this in a fair manner.

Septic systems currently in place have been installed with prior council approval. We are concerned with the Council's broad use of the term "failing" in assessing systems. Verbal assurances were given that every attempt would be made to allow fixing of existing systems before replacement of a failing system, with pump outs, would be enforced.

With the sewerage of Robertson promised for 2002, we will be monitoring the situation closely. To spend money installing a new system for a 3 year lifespan cannot be justified, particuly with the high operation costs associated with pump outs.

The Association has not been idle. We have tried to gather public opinion to make sure we are responsive to your needs. Now comes the crunch, we need to be supported. We need people to attend our meetings, every second month.

The council has deferred a decision on pump outs until some future date. We believe this was, in part, due to the public support provided us in last month's meeting. Such

impacts cannot be achieved if there are but a handful of members.

Robertson is unique. It is isolated and a great place to live. We need to maintain those things that make it so, and fix those things that need fixing. It needs an approach that matches the village's uniqueness, it needs an insiders viewpoint, yours.
